DESCRIPTION

GRAFFITI GARD® IV BIODEGRADABLE CLEANER is a proprietary, state-of-the-art, environmentally-friendly, GREEN cleaner used to clean graffiti off surfaces that have been protected with TEX-COTE® GRAFFITI GARD® IV GLOSS and LOW LUSTER. GRAFFITI GARD® IV BIODEGRADABLE CLEANER is a non-regulated, nearly 0 VOC (<1) cleaner that effectively removes graffiti safely in a short period of time without pungent odors or fumes leaving the GRAFFITI GARD® IV film intact to continue protecting against graffiti.

RECOMMENDED PRIMERS/SUBSTRATES

Use over GRAFFITI GARD® IV GLOSS and LOW LUSTER systems to remove graffiti.

PRODUCT APPLICATION

APPLICATION EQUIPMENT

GRAFFITI-GARD® IV BIODEGRADABLE CLEANER may be applied by brush or roller. Use of a soft bristled brush for scrubbing is recommended for hard to clean areas.

APPLICATION RATE

Quantity of cleaner needed will depend on the amount of graffiti to be cleaned and the surface texture to be cleaned. One quart of cleaner will usually clean approximately 40-50 square feet of affected area.

WORKING TIMES

GRAFFITI-GARD® IV BIODEGRADABLE CLEANER should be allowed to sit on graffiti 10 minutes prior to light scrubbing with soft bristled brush. If the product dries, simple re-wet and continue with scrubbing. Use an additional 5-minute dwell time before rinsing or pressure washing for hard to clean areas.

GRAFFITI REMOVAL

Graffiti should be removed as soon as possible. Prolonged exposure requires more effort to remove. Spray paint graffiti should be removed with GRAFFITI GARD® IV BIODEGRADABLE CLEANER followed by power washing.

- 1. Using a brush or roller, coat graffiti areas liberally with GRAFFITI GARD® IV BIODEGRADABLE CLEANER.
- 2. Allow to sit ten (10) minutes.
- 3. Scrub area with a soft bristled brush. Allow an additional five (5) minute dwell time for hard to clean areas.
- 4. Pressure wash area.
- 5. A second application may be necessary for aged graffiti.

BEST PERFORMANCE

IMPORTANT STEPS

- Conduct cleaning when temperatures are between 45-90°F. AVOID FREEZING.
- Temperatures above 90°F may result in the product drying. If this happens, simply re-wet and continue.
- Remove graffiti as soon as possible for ease of removal.
- A second application may be necessary for aged graffiti.

PACKAGING

Available in one (1) quart and one (1) gallon containers.

COVERAGE RATES

Quantity of cleaner needed will be dependent on the amount of graffiti to be cleaned and the surface substrate. One quart will clean approximately 40-50 square feet. One gallon will clean approximately 170—190 square feet.

SHELF LIFE

6-Month Shelf Life under proper conditions:

- Containers are sealed, upright and airtight in a dry place.
- Maintain temperature of 45°F to 100°F (7°C to 37.7°C).
- AVOID FREEZING.
