Your TEX-COTE® IR System is warranted for as long as you own your home against chipping, flaking, efflorescence, or peeling from the surface to which it is applied. It is also warranted not to Fade beyond five (5) Delta E units for light colors and seven (7) Delta E units for dark colors from the original color at the time of application. If applicable, your vertical wall coating system contains TEX-COTE® COOLWALL® with KYNAR® IR Finish. If applicable, your trim system contains TRIM•COTE® with KYNAR® IR finish. This warranty takes effect on the date of application of the product to your home. If the product fails as described above, Tex-Cote LLC will replace the product, limited to the effected areas.

This warranty only covers products applied to a single-family residence in accordance with our specifications. Non-single-family residences, such as new construction, apartments, condominiums, multi-family dwellings, and commercial use, are excluded from this warranty.

**Notice: Your home is protected with the TEX-COTE® COOLWALL® / TRIM•COTE® with KYNAR® Infrared Heat Reflective coating system. It is a scientific formula. You should not cover up this finish with ordinary paint. If you want to change the color or repaint your home, you should use a TEX-COTE® COOLWALL® / TRIM•COTE® with KYNAR® finish coat that may be obtained by contacting your TEX-COTE® representative, by emailing info@texcote.com or by calling Tex-Cote LLC's National Customer Service Department at 1-800-454-0340.**

This warranty is transferable one (1) time, if transferred to a purchaser of your home within five (5) years after the Date of Application of the product to your home. The Fade portion of this warranty is not transferable. In order for the warranty to be transferred, a written notice must be sent to Tex-Cote LLC within thirty (30) days of the sale of your home. To confirm that the warranty transfer has been processed by Tex-Cote LLC, we will send a new warranty out to the purchaser of the home. In all other instances, the warranty is extended only to the original purchaser of the product.

For breach of warranty as a result of a defect in product, product replacement is our only responsibility and your only remedy. Tex-Cote LLC shall have no responsibility to apply the replacement product or to pay for or contribute to the cost of labor for such application.

This warranty does not cover damage resulting from the settling of the building, major building movement, cracking, water intrusion from the roof, leaks from windows or caulk joints, acts of God (e.g., windstorms, hail, flood, hurricane, tornado, earthquake), or mechanical or external physical causes. This product warranty excludes the application of any TEX-COTE® product over masonite or any other wood-fiber composite siding.

We make no other express warranties to consumers. The terms of this warranty are not subject to modification. The sales representative and/or contractor is not an agent or employee of Tex-Cote LLC and any additional promises or guarantees made by the sales representative and/or contractor shall not become part of this limited warranty.
